STUDENT PARKING IS A PRIVILEGE: Due to very limited parking, permits are restricted for Juniors and Seniors only, available on a first-come-first-serve basis. ***You must bring a copy of your driver license at the time of purchase.*** Students who do not follow the conditions stated below will be subject to disciplinary action, which may include suspension, loss of permit and/or Saturday School.

PARKING PERMIT FEE: There will be a charge of \$155 (cash) or \$160 (Credit Card) for the first vehicle parking non-transferable sticker. \$50 for a second vehicle parking sticker. There is no discount for electric vehicles.

LIABILITY: Vehicle owners are required by California law to carry liability insurance. The Oak Park Unified School District and Oak Park High School assume no responsibility for damage or theft to vehicles. Students park on campus at their own risk.

CONDITIONS:

- 1. SAFETY:** This is a prime consideration in driving. Student drivers are required to follow all California vehicle codes while operating their vehicles on and around campus.
- 2. PARKING:** Students may not park in the staff, visitor or library parking areas. Students may **ONLY** park in the student lot. A valid parking sticker must be displayed at all times. Vehicles without a sticker are subject to towing.
- 3. SPEED LIMIT:** Ten (10) miles per hour is the speed limit on campus.
- 4. LEAVING CAMPUS:** Students may drive their vehicles off campus during their lunch period **ONLY IF** they have a valid Off-Campus Privilege Pass.
- 5. STUDENT RIDERS:** Students may not allow any unauthorized students to be passengers in their vehicle during the lunch period.
- 6. NUTRITION:** The parking lot is considered off limits during nutrition and between classes. Students may not leave campus at any time (other than lunch or after school) unless they have checked out through the Attendance Office.
- 7. VEHICLE SEARCH:** Students issued parking permits may be subject to a vehicle search with reasonable cause.
- 8. LUNCH:** Students are not allowed to hang out or sit in their vehicles during lunch.
